WHO WE ARE: The Southeastern Indiana Recycling District (SEIRD) employs 22 individuals at 8 Recycle Centers and 7 Re-Use Centers throughout the 7 counties in our solid waste management district. We are a multi county cooperative under the supervision of a board of directors made up of 21 local elected officials. Our counties comprise nearly 2,100 square miles consisting of 154,000 residents. The SEIRD Offices, the Event Center, and the Processing Center are located in the Jefferson Proving Grounds, just north of Madison.

<u>OUR MISSION</u>: The Southeastern Indiana Recycling District exists to promote and practice good environmental stewardship throughout Franklin, Jefferson, Jennings, Ohio, Ripley, Scott, and Switzerland Counties. 2024 Looking Back

The recycling data that SEIRD annually collects typically reveals a great deal about human activities and reactions, trends in manufacturing and industry, and economic conditions. In 2024 SEIRD saw a great deal of consistency with the prior year. Recycling volumes and participation, in most areas, realized both slight increases and slight decreases. Here are some observations.

- Standard recyclable materials showed an increase of 3.4% over 2023. The largest increase being fiber (cardboard, paper, etc.), which realized an additional 67,000 lbs. This is likely an indicator that online shopping continues to grow.
- Non-Standard recyclables proved to be very similar. There were small increases and decreases in the "difficult to dispose of items" that SEIRD receives. The one significant change was scrap metal. SEIRD collected 26,000 lbs. less in 2024 than in 2023, resulting in an overall non-standard collection decrease of 2%. The reason for this decline is two-fold: 1) "scrapping" has become popular again as metal prices have increased and 2) Madison now has a heavily utilized scrap yard that has captured much of the materials typically brought to recycle centers. In all, this is not a negative as our goal is to simply see that materials are properly recycled, regardless of who does the collecting.
- An observation worth noting this year is the increase in curbside collection. Having consistently dropped 4% to 5% over the last few years, curbside rebounded slightly with a 1% increase in collection in 2024.
- Lastly, a concerning observation. Unfortunately, it's not uncommon to read some negativity about recycling these days. Typically, these are just opinion statements. Many do not understand that large waste and recycling companies want every ounce of recyclable material they can get. They have many millions of dollars invested and need that material to pay for machinery and labor. Recycling will forever be critically important as ALL items come from some form of natural resources, which we cannot afford to waste.

2025 Looking Ahead

- While SEIRD will always continue working to grow, expand and improve the recycling opportunities throughout the seven county district, education will be a big focus in 2025. Look to see an increase in educational programs for both youth and adults throughout the entire district.
- SEIRD's very popular Difficult Disposal Program (amnesty opportunities) are once again available from May through August:
